Thank you for choosing to submit your paper to us. These instructions will ensure we have everything required so your paper can move through peer review, production and publication smoothly. Please take the time to read and follow them as closely as possible, as doing so will ensure your paper matches the journal's requirements. #### **Word limits**

Please include a word count for your paper.

A typical article for this journal should be no more than 8000 words; this limit does not include appendices which will be published in online only supplemental files; this limit includes tables, references, figure captions, endnotes. A typical viewpoint for this journal should be no more than 2000 words; this limit includes tables, references, figure captions,

endnotes. A typical report for this journal should be no more than 2000 words; this limit includes tables, references, figure captions, endnotes.

Please use British -ize spelling style consistently throughout your manuscript.

Please use single quotation marks, except where 'a quotation is "within" a quotation'. Please note that long quotations should be indented without quotation marks.

Articles should be written in the third person, impersonal style, and the use of 'I/we' should be avoided.

### **Formatting and templates**

Papers may be submitted in any standard format, including Word. Figures should be saved separately from the text. To assist you in preparing your paper, we provide formatting templates.

Legal references and statutes should be accompanied by a full reference in the reference list with a URL where possible. If this material does not fit into standard reference format or contains lengthy URLs, it should be put into a separate Appendix for online only publication in the supplemental file.

Any figures, tables or text to be included as supplemental data should be submitted in a separate document clearly marked 'supplemental'. Any figures or tables should be numbered as A1, A2, A3 etc, in separate sequences from figures and tables appearing in the main text. This material will not be copy-edited or typeset, and should be supplied as the author wishes it to appear when accessed online.

If there are figures in the main article, and other figures in the online appendix, then they should be numbered as two separate sequences. The figures in the main article should be

referred to as Figure 1, Figure 2, etc, and the figures in the Appendix should be referred to as Figure A1, Figure A2, etc. Both sets of figures must be mentioned in the text of the article, although the Appendix figures will only appear in the online supplemental file. The same applies to tables.

## Checklist: what to include

1. **Author details.** Please include all authors' full names, affiliations, postal addresses, telephone numbers and email addresses on the title page. Where available, please also include [ORCID identifiers](#) and social media handles (Facebook, Twitter or LinkedIn). One author will need to be identified as the corresponding author, with their email address normally displayed in the article PDF (depending on the journal) and the online article. Authors' affiliations are the affiliations where the research was conducted. If any of the named co-authors moves affiliation during the peer-review process, the new affiliation can be given as a footnote. Please note that no changes to affiliation can be made after your paper is accepted. [Read more on authorship](#).
2. A non-structured **abstract** of no more than 100 words. Read tips on [writing your abstract](#).
3. You can opt to include a **video abstract** with your article. [Find out how these can help your work reach a wider audience, and what to think about when filming](#).
4. 4-6 **keywords**. Read [making your article more discoverable](#), including information on choosing a title and search engine optimization.
5. **Funding details.** Please supply all details required by your funding and grant-awarding bodies as follows:

8. **Supplemental online material.** Supplemental material can be a video, dataset, fileset, sound file or anything which supports (and is pertinent to) your paper.
